- Proofs should be typed out. Reference citations may include internet links (*the Chicago Manual of Style format is preferred*).
- The application and copies of documents must be on 8-1/2 x 11 acid-free paper.
- Only submit one proof document for each generation.

#### • Return Application

- The application must be signed and notarized.
- Include a check for \$31 made out to Siege of Bexar Descendants.
- Return the signed and notarized application, the proof documents and check to: Registrar, Siege of Bexar Descendants, -----, Kerrville, TX.

### Membership Eligibility

Any person of good moral character who is a direct descendant of a veteran of the Siege & Storming of Bexar is eligible for membership in the Siege of Bexar Descendants organization. A deceased person otherwise qualified may hold Posthumous Membership.

The Siege of Bexar began in October of 1835 and the final Assault on San Antonio occurred 5-10 December of that year. It is also known by other names, e.g. "The Battle of Bexar" and "The Assault on San Antonio". A veteran is anyone who served there in any capacity as a member of the Texian army.
